NOTICE OF RACE

ELIGIBILITY

Self-righting sailing vessels whose length overall is 19' or greater. Other yachts may participate at the discretion of the Chatham Sailing Club Race Committee, as organizing authority.

CLASSES

Class A (Spinnaker yachts)
Class B (Non-Spinnaker yachts)

Classes may be changed or subdivided at the discretion of the Chatham Sailing Club Race Committee. At the discretion of the Race Committee, three or more yachts of the same design may be designated a separate one-design class or sub-class.

RULES

This regatta will be governed by the Racing Rules of Sailing 2013-2016 as adopted with prescriptions by the United States Sailing Association and the rules of competing classes racing, subject to such changes as may appear in full in the Sailing Instructions.

FEES

The entry fee is \$50.00, which includes Oktoberfest Beer Garden access for skipper and crew, one ticket for the Oktoberfest dinner following Saturday's racing and one Regatta tee-shirt. U.S. Sailing members will receive a \$5.00 discount. Additional dinner tickets and tee-shirts will be available for purchase.

ADVANCE REGISTRATION

Competitors should register in advance by completing the Oktoberfest Registration Form located on page 3 of this NOR. Competitors who have not pre-registered may register from 5:30 p.m. to 7:30 p.m. at the Chatham Sailing Club on Friday, September 25, 2015.

RATINGS

Ratings will be assigned by the Chatham Sailing Club based on the most recently published History of US PHRF Affiliated Fleet Handicaps published by U.S. Sailing.

ADVERTISING

Advertising shall be in accordance with ISAF Regulation 20.

SAILING INSTRUCTIONS

The Sailing Instructions will be available at registration. Courses will be defined in the Sailing Instructions. Racing will take place on the Wilmington River and Wassaw Sound.

SCORING

A maximum of 7 races are scheduled, of which 1 shall be completed to constitute a series. If 5 or more races are sailed, a boat's worst score shall be discarded. This changes rule A2.

PRIZES

Prizes shall be awarded to the first three boats in each class.

The responsibility of wearing a life jacket rests upon the Skipper/Owner and their crew. If assistance is provided by committee vessels and personnel, it is at the risk of the participants. I accept full responsibility for the conduct of each member of my crew and guests during the Regatta. I acknowledge that I have sole responsibility for the safety of my crew and oddslot football predictions.
